Pursuant to Regulation 30 read with Schedule III of the Listing Regulations, please find appended below the summary of proceedings of 14<sup>th</sup> Annual General Meeting of the Company:

- The 14<sup>th</sup> Annual General Meeting ("AGM") of Suumaya Corporation Limited (formerly known as Rangoli Tradecomm Limited) ("The Company") was held on Friday, September 29, 2023, through Video Conferencing ("VC") / Other Audio Visual Means ("OAVM") facility. The Meeting was scheduled at 03:30 PM and concluded at 03.43 p.m.
- 2. The AGM was held through VC in compliance with the circulars issued by the Ministry of Corporate Affairs ("MCA"), and the Securities and Exchange Board of India ("SEBI"). The Company had provided video conferencing facility for the AGM.
